

# REBUILD TO SERVE CAMPAIGN FREQUENTLY ASKED QUESTIONS

## HOW WILL WE APPROACH AND MANAGE THE CONSTRUCTION AND WHAT'S THE ANTICIPATED TIMELINE FOR COMPLETION?

**Scope:** Rebuild an expanded Fr. John Giuliani Parish Center on the existing location and build a new, 2 story building that will house the St. Philip Neri Child Development Center on the first floor and a future Parish Activity Center on the second floor. The Parish Activity Center will provide additional ministry, meeting, and formation rooms as we continue to respond to the needs of our growing faith and local community.

**Approach:** The first phase of construction will be to build the new, 2 story building that will house the Child Development Center on the 1st floor and the Parish Activity Center on the 2nd floor. Once this building has been completed and the Child Development Center has taken occupancy, the existing Parish Center building will be razed, and construction will begin on the expanded Parish Center.

**Anticipated Timeline:** We anticipate that construction for the new 2 story Child Development Center/Parish Activity building will take 16 months, and construction on the new Fr John Giuliani Parish Center building will take between 12-14 months.

## HOW WILL WE MANAGE THE IMPACT ON THE MINISTRIES, ORGANIZATIONS AND EVENTS THAT UTILIZE THE PARISH CENTER DURING THE CONSTRUCTION OF THE EXPANDED PARISH CENTER?

Jim Funk, Chair of the Rebuild to Serve Planning Committee will work with the Building Committee to develop a facilities plan that will best support the continuation of ministry and organization activities to minimize disruption. This is especially important for our Italian Festival, St. Philip Neri World Hunger Drive Meal Packing Event, Martha's Meals, K of C Sponsored Events such as the Blood Drive, Scouts, and Youth Formation, etc.

We recognize that undertaking a project of this magnitude will present some hardships and challenges as we continue to serve our parish and our community, and we are grateful for your support and patience.

## DID ST. ANNE'S HIGH SCHOOL FACTOR INTO THE FEASIBILITY STUDIES AND SUBSEQUENT REBUILD TO SERVE PLAN, AND IF THEY DIDN'T OCCUPY THE SECOND FLOOR OF THE ST. PHILIP NERI MINISTRY BUILDING, HOW WOULD THIS IMPACT THE REBUILD TO SERVE PLAN?

St. Anne's High School facility need was not factored into the Rebuild to Serve Plan. This is a lease relationship with St. Philip Neri for the top floor of the Ministry Building during school hours. This space is utilized by St. Philip Neri ministries in the evening hours and on the weekends. St Anne's is currently working on a long-term plan to address their facility needs.

It should also be noted that the size of these classrooms cannot support our growing youth formation program. 🏠
