For many years, St. Philip Neri Church ("SPN") has strongly supported those parishioners that have their children educated in Catholic schools. SPN believes that we share in the teaching mission of Christ, and that Catholic education is an integral part of the faith formation of our parish mission. Just as those who have gone before us, we're called to nurture our Catholic faith through our formative years, we too are called to pass on our faith to another generation of God's children and those who will come after us. As such, Catholic education is the responsibility of the entire parish community.

In our continuing effort to support Catholic education, we are pleased to offer financial assistance/parish subsidy to partially offset tuition costs for qualifying families that choose to provide a Catholic school education for their children during the 2026/2027 school year. In partnership with Catholic schools in York County, SC and Mecklenburg County, NC, we hope to assist families in meeting the financial demands of a Catholic education. Catholic schools prepare students to be faithful disciples of Christ, the whole person – spirit, mind, and body – through spiritual and academic formation based on the Gospel of Jesus Christ.

## MACS Parish Subsidy Policy

- The Program only applies to students entering kindergarten through the 12th grade for the 2026/2027 school year. Families are required to re-apply for financial assistance **each school year**.
- If a family registers at SPN during the school year, a letter from the applicant's former parish must be submitted, indicating that the family has been active and participating in the former parish for a six-month period.
- Submit the Application Form to the Parish Office as applicants will be reviewed in the order in which they are received.
- Recipients of any parish subsidy will be notified on a rolling basis via email.
- **The application for MACS enables a parishioner to be eligible for the Parish subsidy provided by SPN to offset tuition. Applicants must submit a MACS voucher Form from MACS area for Approval, along with this parishioner info application. The MACS voucher form will not be reviewed/approved until all forms are submitted. If you are seeking the parish subsidy from St. Philip Neri, check the box "MACS Parish Subsidy for Catholic Education.**

## Criteria for Qualification

SPN parishioners with children that attend Catholic school may be eligible for F.A.C.E. The following criteria **must** be met:

A family **must** be active in and participate in the life of the parish (collectively, the "Active and Participating Parishioner Policy").

- Be a registered parishioner at SPN for a minimum of six months.
- Participate in the life of the parish through attendance at weekly Mass and Holy Days of Obligation and devoting time to daily prayer.
- Participate in the life of the parish by serving through active participation in at least one SPN ministry.
- Financially support the parish by giving a portion of your financial resources to SPN using weekly envelopes or other identifiable means.

- A Discipleship Commitment Card, distributed as part of SPN's annual Stewardship Renewal Program, **must** be on file in the Parish Office.
